Labour – Jake Berg indicated that there was an issue with the timely receipt of passports in Nicaragua.

Stock Replacement – Ron Greidanus reported that there has been an issue concerning the timely release of stock in Toronto. Osee Podolsky reported the issues with UPS and queen deliveries.

Honey/Food Safety – Nothing to report

Pollination/Interprovincial movement – Maggie Lamothe Boudreau that despite the fact that in Quebec there are colonies available for blueberry pollination, growers are buying bumble quads instead. Approximately 7000 quads have been purchased at \$300 per while honeybee pollination contracts are \$225.00.

Maggie and Rod will get more information on the situation to the Board. Hive Health – John Van Alten indicated that it was difficult to get Oxytet in Ontario.

Tech Transfer Team Liaison – Rodney Reid and Jeremy Olthof reported that a revised letter of intent was drafted and has been distributed to AAFC officials and the Standing Committee on Agriculture and Agri-Food.

b) ABC Sustainability project – Ron Greidanus suggested it be removed from the agenda

c) Tropilaelapse – Rod is working with Sam Muirhead in getting a small committee together.

d) Foster project – Nothing to report

e) Quinclorac update – Over 600 data samples have been sent to representatives working with the Japan Honey Fair Trade Council and to the CFIA contact at the Canadian Embassy. In addition, data results from Alberta and Saskatchewan are forthcoming in the BeeMaid grant project.

7. Board/Executive Director Reports

Rodney Reid indicated that the weather has been extremely poor. The Nova Scotia blueberry crop is ahead of schedule and pollination is coming quickly. Maggie Lamothe Boudreau reported that with a couple of exceptions, the bees came out of winter pretty good. Results from the organic study on bee feed will be available soon.

John Van Alten reported that the apple bloom is nearing completion and the beekeepers are getting ready for blueberry pollination.

Ron Greidanus reported that it looks like 25-30% losses in Alberta with some high loss cases. Packages have been arriving and there seems to be a shortage of queens. Honey prices appear to be softening. There has been a few colony losses as a result of fires but more importantly it seems to have moved the bears into more apiary locations.

Jeremy Olthof said that high mite colonies were rounded up for Rassoul's research project. The Alberta Tech Transfer Team has found significant lingering viral symptoms in some apiaries.

Stan Reist reported that hot dry weather was preceded by cold wet weather. Blossoms are finishing up on the Island. Beekeepers are experiencing thefts of colonies and nucs. Queen sales have been steady.

Jake Berg reported that smoke moved into the territory. His operation had poor overwintering success.
